3. The base price/rate of canteen shall be minimum **Rs. 2000/- per month**.
4. The contractor has to deposit security money of **Rs. 8000/-** (Refundable at the end of the session) before taking over the charge of canteen.
5. Canteen shall start from 17th August 2026.

TERMS & CONDITIONS OF CONTRACT FOR CANTEEN ON RENT BASIS

1. The Canteen will function from 17th August 2026 to 30th April, 2027.
2. The forms can be obtained either from college website or the office of the Senior Assistant from 27.07.2026 (10 AM) to 05.08.2026 before 5:00 PM.
3. The Filled up forms must reach the office on or before 05.08.2026 till 5:00 PM. No forms will be accepted after 5:00 PM.
4. Minimum Bid amount is Rs. 2000/- and highest Bidder will be the winner. The slack period will be decided thereupon by the institution.
5. There should be no ongoing vigilance inquiry against the contractor/its partner/employees and he/she has never been convicted or punished by any Honorable Court of Law and not black listed/debarred/deregistered by any government/government undertaking in India.
6. If the Contract is broken for any reason by the winner of the Bid, the Security amount will not be refunded.
7. The rent after the highest Bid will be deposited in college office within five days after the allotment of the canteen.
8. The rent must be deposited from 1st to 5th of every month after the completion of month.
9. Any delay in paying the Canteen rent within due dates, the Contractor has to deposit the rent with 10% interest. If the Contractor fails to deposit the rent before 15th of the month, the Contract will be broken and the Security amount will not be refunded.
10. When the winner of 1st Bid fails to continue, 2nd and the 3rd highest bidder will be given the Canteen.
11. The Canteen furniture table/chair (allotted Nos.) can be used by the Contractor who wins the Bid.
12. Gas Cylinder, Utensils, etc. all will be of the Contractor. The College will not provide anything. (No Gas Cylinder, no utensils and other items)
13. The Canteen will run from 09:00 AM to 05:00 PM.
14. No one is allowed to remain or reside in the Canteen after 05:00 PM. If anyone found after the mentioned time, can be penalized each time of Rs 1000/- (except in some exceptional cases or after the permission of head of the institution). If the breach continues for more than four times, the Contract will be immediately terminated and security amount will not be refunded.
15. Smoking and drinking (alcohol) in the Canteen shall breach the Contract of canteen and security amount will not be refunded.
16. Plastic material is prohibited except packed water bottle/Juice/eatables and further avoids the practice of junk food.

17. A nominal/lump-sum fixed electricity bill (i.e. of Rs. 500 per month) will be paid by the Contractor on monthly basis until the new Sub-Meter will be installed.
18. Waste material will be disposed off by the Contractor at proper place.
19. Hygiene will be the top priority and it has to be maintained by the Contractor.
20. Expired items if sold, the Contractor will be penalized Rs.500/- for each such breach.
21. All legal formalities will be followed by Contractor in engaging the employees and the workers as per govt norms. And the employees of the contractor will wear the identity cards given by the college authority.
22. The firm/contractor would require using ISI/agmark/food grade products as per FSSAI norms.
23. No private persons including any former student or any citizen will be allowed in the Canteen after working hours i.e. 5:00 PM.
24. Only people coming for some personal/official work in the College will be allowed till 5:00 PM only. On special occasions with the permission of undersigned, the Canteen will be allowed accordingly.
25. The highest Bidder for the rent will be awarded the Contract. In case the winner refused to run the Canteen or shall not deposit the security amount then 2nd highest bidder shall be eligible to run the canteen.
26. In case of a complaint of misbehavior or breach of norms more than 3 times with Teaching, Non-Teaching Staff members and students, the contract will be broken immediately.
27. The operation of the canteen must be started within five days of acceptance of the tender. If the contractor is unable to commence work on time, the principal shall have full authority to terminate the canteen contract.
28. Canteen contractor shall have to provide all the items for programme organized by the college.
29. To play of vulgar songs and excessive sound in the canteen is prohibited. In case of breach of rule, fine can be imposed.
30. In case of violation of any of the above conditions, the Principal, JLN GC HARIPUR, MANALI have the full right to terminate the canteen contract.
